

**ESSEX COUNTY SCHOOLS OF TECHNOLOGY**  
**District Wide Parental Involvement Policy**  
**2018-19**

**PART I.**

Pursuant to Title 1, Part A funds and federal law, the Essex County Schools of Technology agrees to distribute to parents of participating children a written District-wide Parental Involvement Policy in accordance to required information in Section 1118 (a) (2) of the Elementary and Secondary Education Act (ESEA) (District Wide Parental Involvement Policy). The policy establishes the LEA's expectation for parental involvement and describes how the LEA will implement a number of specific parental involvement activities and is incorporated into the LEA's plan submitted to State educational agency (SEA).

The district believes that parental involvement and support of the schools are critical to the success of our schools. The schools will operate better when there is a close relationship among all stakeholders: students, parents, teachers, support staff, administrators and member of the community. To this end, the district will initiate a comprehensive program to increase parental involvement and establish school-home-community partnerships in every school. It shall therefore be the policy of the district to support parent involvement by providing a continuum of parent involvement programs and activities.

The **Essex County Schools of Technology** agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.

- The school district will be governed by the following statutory definition of parental involvement, and expects that its Title I schools will carry out programs, activities and procedures in accordance with this definition:

*Parental involvement means the participation of parents in meaningful communication involving student academic learning and other school activities, ensuring that they:*

*(A) play an integral role in assisting their child's learning;*

*(C) are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;*

*(D) carryout of other activities, such as those described in section 1118 of the ESEA.*

- The school district will inform parents and parental organizations of the purpose and existence of the Parental Information and Resource Center in the State.

  - d. Personal contact by phone, letters and e-mail.*
  - e. Annual Parent Meetings.*
4. The **Essex County Schools of Technology** will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs: [Parent Workshops/ESL Materials, Educational Brochures, Parent Resources materials, Technology Training, Power School Training (Student Information System), PTSA Meetings, Parent-Teachers Conference, School Policies and Dress Code Policy], by:
- a. Freshmen Orientation*
  - b. Annual Parent Meeting*
  - c. Sophomore, Junior, and Senior Class Parent Meetings*
  - d. District-wide School Fair*
  - e. District Parent Advisory Council (DPAC)*
  - f. Providing Monthly Parent Workshops/ESL Materials*
5. The **Essex County Schools of Technology** will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school district will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.
- a. Parents, Teachers, Students, District Parent Coordinator, ESL Supervisor, and Administrator along with a community member will serve on a District-wide Parent Advisory Council (DPAC).*
  - b. The District Parent Coordinator will facilitate the selections of all parents and community members who will serve on the DPAC.*

- c. *The DPAC will review all necessary materials as they relate to parents who are economically disadvantaged, disabled, limited English proficient or any other accommodations.*
  - d. *One committee member will be chosen from each school PTA Executive Board to serve for a period of one school year.*
  - e. *The committee member of PTA and selected school representative will be responsible for assuring that all parents' activities meet the requirement of Title I, Part A schools.*
  - f. *The District Parent Advisory Council (DPAC) will evaluate all materials in assuring that all parental involvement materials represent all parents and students.*
  - g. *District Parent Coordinator will ensure that all activities and parental involvement polices are implemented and parents are a part of all and any planning stages of involvement.*
  - h. *The Parents role on this committee will serve in the capacity of a liaison between the DPAC committee to ensure that information on parental involvement policies and parental involvement activities are implemented.*
  - i. *The District Parent Advisory Council (DPAC) will meet twice a year.*
6. The **Essex County Schools of Technology** will build the schools' and parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement through the following activities described below:

    - e. *Financial Aid Workshop*
    - f. *NJ PTA Conference*
    - g. *National PTA Conference*
    - h. *State Wide Parent Advocacy Network (SPAN) Conference and Workshop*
    - i. *LEA State and local Assessment policies*

*j. Parents-Teachers conferences*

B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate to foster parental involvement, by using the following activities:

- a. Training on using Power School Parent Portal*
- b. Training on New Jersey Student Learning Standards*
- c. Training on Assessments for ESL students*
- d. Providing materials in English/Spanish to parents*
- e. Providing One to One Parent/Teachers Conferences*
- f. Facilitating Classroom visitations*
- g. Facilitating Grade level meetings*
- h. Providing training on using Technology to improve learning*

C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff on how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by the following activities:

- a. The school and parents of participating students jointly develop school-parent compact, which defines the shared responsibility of improving student's academic achievement.*
- b. Parents are notified at the beginning of the school year of their right to know the qualifications of their child's teachers and paraprofessionals.*
- c. Parent of limited English proficient children placed in a language instruction educational program must be notified no later than 30 days after the start of school year, of reason for child's placement and the child's level of proficiency.*
- d. Parents of students enrolled in a Title I Targeted Assistance school must be notified that their child has been identified as eligible to receive Title I service based on specific entrance criteria.*
- e. The school will provide information that builds ties between parents and school through the Annual Parent Meeting and Monthly PTA Meetings.*
- f. District Wide Parental Involvement Policy, Parental Involvement Policy, and School-Parent Compact issue to all Parents of Title I, Part A students.*

D. E. The school district will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- a. *Monthly mailing of all meeting and activities (English & Spanish)*
- b. *Robo Call (Telephone) (English and Spanish)*
- c. *Email*
- d. *Text Messaging (Upon parent request)*
- e. *Power School Parent Portal*
- f. *School website, Google+*



**PART IV    ADOPTION**






