DESCRIPTION

The New Jersey Department of Transportation (NJDOT) is seeking candidates for the position of **Plumber and Steamfitter** within the division of Transportation Operations Systems & Support, Support Services, Regional Facilities Management. Plumber and Steamfitters are assigned a 40 - hour work week. Current starting salary is between \$42,112 and \$47,823, based on experience. As a NJ State Department, NJDOT offers a comprehensive benefits package including Health Care (medical, prescription drug, dental, and vision care), Pension, Deferred Compensation, 12 paid holidays, and Benefit Leave (12 vacation days, 15 sick days, and 3 administrative days).

The Division of Transportation Operations Systems & Support (TOS&S), Support Services is responsible for the upkeep and maintenance of the New Jersey Department of Transportation's (NJDOT) facilities and grounds statewide, which include the Main Headquarters Complex in Ewing, Regional Headquarters Buildings, Maintenance Yards, Rest Areas, Weigh Stations, Airports, etc. It also provides centralized services, such as: warehouse and shipping, receptionist, cashier, and mail room, amongst others.

Under the direction of a Supervisory official, will perform various types of plumbing assignments involving the installation, repair and maintenance of plumbing and steam fitting fixtures, fittings and systems. The position will perform assigned duties throughout numerous NJDOT facilities located in our Central Region on a daily basis, which include the following counties: Hunterdon, Somerset, Mercer, Middlesex, Monmouth and Ocean. A State issued vehicle will be provided to perform these assignments.

APPOINTEES TO THIS POSITION ARE SUBJECT TO CIVIL SERVICE COMMISSION TESTING AND MUST PLACE HIGH ENOUGH ON THE SUBSEQUENT EMPLOYMENT LIST FOR PERMANENT APPOINTMENT.

REQUIREMENTS

Experience:

Three (3) years of broad experience in work involving the installation, inspection, repair, and maintenance of plumbing and steam fitting fixtures, fittings appliances, machinery, and plumbing systems.

License:

Appointees will be required to possess a driver's license valid in New Jersey.

Work Authorization: Applicants must be authorized to work in the United States according to the Department of Homeland Security, United States Citizenship and Immigration Services regulations. NJDOT does not provide sponsorship or accept student OPT/CPT program, F1 or H1B work authorization visas.

Residency: All persons newly hired on or after September 1, 2011 have one year from the date of employment to establish, and then maintain principal residence in the State of New Jersey subject to the provisions of N.J.S.A. 52:14 - 7 (L.2011, Chapter 70), also known as the "New Jersey First Act."
