Acceptable Proofs of Residency

Please provide three (3) of the following proofs of residency:

- Driver's license or Identification Card – Must be current
- Most Recent Utility bills –Must contain home address
- Employment documents and/or government benefits statement – Must contain home address
- NJ Division of Elections Sample Ballot – Must be from the current year
- Current lease – Can include lease from Housing Authority or letter from a homeless shelter
- A domicile affidavit verifying student lives at address - Maybe a notarized affidavit, along with a copy of person' lease
- Property tax or income tax bill - Must be from past year and contain home address
- Mortgage statement – Must be current and contain home address
- Bank or other financial account statement - Must contain home address
- Ongoing payment obligation issued by verifying third party - Must contain home address. Ex: Car payment, insurance payment, student loan payment, etc.
